**Tuition is \$6,000.00.** This includes tuition, supplies, horseshoes, nails textbook, use of MSU farrier school forges and anvils, and insurance. Does NOT include price of tools.

NOTE: Deposits will be refunded ONLY if the student cannot attend the school for unavoidable reasons and the request is made AT LEAST 60 DAYS prior to the start of class. If the refund is approved, \$1,000 will be refunded and \$200 kept as an office charge. If a cancellation/transfer is made LESS THAN 60 days prior to the start of class, the deposit will NOT BE refunded/transferred. **International students must pay full tuition with application to be in compliance with MSU policies regarding passport, Visa and any other necessary paperwork.**

The balance of the tuition (\$4,800) will be due 45 days before the first day of class. Noncompliance with these rules could result in removal from the class. PLEASE NOTIFY THE SCHOOL OF ANY CHANGES OF ADDRESS OR PHONE NUMBER IMMEDIATELY.

If you are applying for VA, WIA, or any other funding, get your paperwork started as soon as possible in your hometown. It takes weeks for your checks to start coming, and you will be without this money unless you plan ahead. It is not the responsibility of the school to do this for you. Regardless of funding sources, full tuition payment is required by the deadline date before start of class.

Working with horses, hot steel and sharp tools involves inherent risks of serious physical injury. I fully realize the dangers of participating in this activity and voluntarily assume all risks associated with such participation. The Horseshoeing School has a mandatory accident insurance policy, which covers the student ONLY WHILE IN CLASS. It is limited to a maximum of \$2500 medical, \$250 dental, \$2500 death or dismemberment and is subject to a \$150.00 deductible. The costs of this policy are included in the tuition. Any medical or dental costs not covered by this insurance policy are the sole responsibility of the student.
